This application must be accompanied by an appropriate bank transfer receipt to reimburse the operating expenses of the Scientific Committee of the Foundation, referred to in the Table, attached hereto under letter A), it forms an integral part of it, it being understood that in no circumstances shall the sums paid be reimbursed in the event of a negative outcome of the application; however, in the event of a positive outcome, the amount already paid shall be counted as a deposit on the service provided by the Foundation.

2 The direct examination of the work and all related documentation shall be carried out collectively by the Scientific Committee pro tempore of the Marino Marini Foundation only at the time of the material delivery of the work to the headquarters of the Marino Marini Foundation or other location indicated for this purpose, on the date of convocation that shall be communicated for this purpose to the interested parties.

3. The inclusion of the work in the Archives of the Marino Marini Foundation is subject to the positive outcome of the said direct and collective examination, with consequent unanimous opinion on the attributability of the work to Marino Marini.

4. In the event of a favourable opinion from the Scientific Committee, the inclusion of the work in the Archives shall be certified by the assignment of the archive number shown on the certificate delivered to the owner/applicant. Under no circumstances shall the Marino Marini Foundation issue copies of a certificate already issued.

5. The rejection of the request for inclusion of the work in the Archives, following its direct examination together with all the documentation, shall be communicated to the owner/applicant by email to the address provided through a brief statement of the reasons on which the negative opinion expressed unanimously by the Scientific Committee is based.

6. In addition to the provisions of the previous points, the owner/applicant undertakes, at his/her sole risk, responsibility and expense to:

A) send to the headquarters of the Marino Marini Foundation, by the deadline indicated by the latter, the work to be examined together with this form in the original, duly signed for acceptance and together with the documentation required on the work;

B) maintain the work and all related documentation at the disposal of the Marino Marini Foundation for the time necessary to carry out all the investigations that shall be deemed necessary;

C) promptly collect the work at the request of the Foundation.

7. The precise fulfilment by the owner or applicant of all the above is a necessary condition for carrying out the direct examination of the work presented, failing which the examination cannot take place.



8. The owner or applicant hereby accepts and without reservations, conditions or exceptions the opinion, positive or negative, that shall be expressed by the Marino Marini Foundation in the manner referred to in points 2), 3), 4) 5) and 6) above, expressly acknowledging the authority, impartiality and competence of the Scientific Committee and the various consultants who, at the discretion of the Marino Marini Foundation, may be called upon to analyse aspects and/or elements of the work for an objective opinion on the matter.

9. Any and all legal claims against the Marino Marini Foundation, the members of the Scientific Committee pro tempore and other consultants concerning, by way of example only, disputes over the opinion issued to the applicant, compensation for consequent damages and any other action relating to the refusal of inclusion of the work in the Archives are hereby expressly waived for whatever reason.

10. Any and all actions or claims against the Marino Marini Foundation, the members of the Scientific Committee pro tempore and other consultants for losses and/or damage that the work under examination may suffer for the duration of the stay on the premises of the Foundation are hereby deemed waived for whatever reason.

11. The content of this application, the interpretation of each of its clauses and every aspect of the relationship between the Parties not expressly agreed herein shall be entirely governed by Italian law.

12. Any dispute that may arise in relation to the interpretation or execution of this application or concerning claims related to or consequent on it, shall be subject to Italian law and to the exclusive jurisdiction of the Courts of Rome.

PRIVACY POLICY

We would like to inform you that Regulation (EU) 2016/679 (GDPR) protects the fundamental rights and freedoms of natural persons, in particular the right to the protection of personal data.

PURPOSES AND LEGAL BASIS OF THE DATA PROCESSING: The personal data provided by you after completing the deposit form (first name - last name - address - property) shall be processed for the following operations expressly requested by you: examination of the work deposited according to its archiving, whether deemed authentic; publication and reissue of Marino Marini's Catalogues of Works; exhibitions in museums, exhibition spaces and other bodies and related publications; the processing shall have its own legal basis in the Agreement you entered into with the Marino Marini Foundation and shall be functional to execution of the same;

3. RECIPIENTS OR CATEGORIES OF RECIPIENTS OF THE PERSONAL DATA: The data may be communicated to third party curators of the aforementioned Catalogues, publishing houses, museums and public institutions for exhibitions and related catalogues, as well as to professionals who provide their activities in favour of the Marino Marini Foundation according to the aforementioned activities (Lawyers, Technical Consultants, etc.);

4. POSSIBILITY OF TRANSFERRING DATA ABROAD: As part of the processing described above, your data may be communicated to parties established outside the territory of the EU, always in compliance with the conditions and requirements of Chap. V of Regulation (EU) 2016/679 (GDPR);

5. STORAGE PERIODS FOR PERSONAL DATA: In view of the nature of the processing, consisting in the inclusion of personal data in the archives that the Marino Marini Foundation maintains and keeps updated, the data shall be retained indefinitely, at least for the entire duration of the Foundation's institutional activity;

6. RIGHTS OF THE DATA SUBJECT: You are entitled to:

- Access your personal data;
- Ask for its correction;
- Ask for its deletion;
- Ask for the limitation of the processing that concerns you, without prejudice to the requirements relating to the performance of the contractual relationship that constitutes its legal basis;
- Oppose processing that is not necessary for the execution of the contractual relationship with our company;
- Obtain the portability of your personal data.

7. RIGHT TO LODGE A COMPLAINT WITH A SUPERVISORY AUTHORITY: In the event of breaches of contract concerning the lawfulness of the processing of your personal data, you have the right to lodge a complaint with the Data Protection Authority;
